# Medicaid Mental Health Services Individuals 18 years of age and older Fee Schedule Effective July 1, 2021

## **Acute Inpatient Services**

Acute care hospital services will be reimbursed for Medicaid members under the Montana Medicaid program's Diagnosis Related Group (DRG) reimbursement system. All out-of-state admissions of Medicaid members require prior authorization.

#### **Evaluation and Management Services**

Evaluation and management (E/M) services may be provided by physicians and other qualified health care professionals. Providers bill using standard CPT E/M procedure codes and are reimbursed according to the Department's RBRVS system.
