

# Medicaid Applied Behavior Analysis Services Fee Schedule

## July 1, 2022

### I. Applied Behavior Analysis Services

The Board Certified Behavior Analyst (BCBA) assumes full professional responsibility for all services provided by an intermediate professional or registered behavior technician (RBT). All services are billed under the BCBA's provider NPI. Providers bill using standard Current Procedural Terminology (CPT) procedure codes and are reimbursed according to the Department's RBRVS system.

Applied Behavior Analysis Services do not require co-pay.
